Agreement Scope and Territory and Definitions. This agreement shall be legally binding upon me,

_the registered student, and the parents or legal

(Print your full name) guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of the state and county of BLACK FOX FARM LLC's physical location. This agreement is intended to be valid and binding at all times now and in the future when BLACK FOX FARM LLC permits me (directly or indirectly) to enter BLACK FOX FARM LLC's property, be on BLACK FOX FARM LLC 's property, be near any horse, receive riding and/or training instruction or guidance from its associates and/or when I ride and/or train and/ or am near horses on or off of BLACK FOX FARM LLC's property. Any disputes by the rider shall be litigated in Sagadahoc County, Maine. This agreement is intended to be as broad and inclusive as the law permits. If any clause, phrase, or word is in conflict with state law, then that single part is null and void. The terms "HORSE" and "EQUINE" herein shall refer to all equine species. The terms "I", "WE", "ME", "MY", shall herein refer to the above registered student and the parents or legal guardian thereof if a minor.

- C. __/___ Inherent Risks/Assumption of Risks. I/WE ACKNOWLEDGE THAT: Risks, conditions, and dangers are inherent in (meaning an integral part of) horse/equine/animal activities, regardless of all feasible safety measures, which can be taken, and I agree to assume them. The inherent risks include, but are not limited to any of the following: The sudden movement, unfamiliar objects, persons, or other animals, Hazards, including, but not limited to, surface or subsurface conditions; A collision, encounter and/or confrontation with another equine, another animal, a person, or an object; The potential of an equine activity participant to act in a negligent manner that may contribute to injury, harm, death, or loss to the participant or to other persons, including but not limited to, failing to maintain control over an equine and/or failing to act within the ability of the participant. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from horse to ground it will generally be at a distance of from 31/2 to 51/2 feet, and the impact may result in harm to the rider. Horseback riding and training are activities in which one much smaller, weaker predator animal (the human) tried to impose its will on, and become one unit of movement with, another much larger, stronger prey animal that has a mind of its own (the horse) and each has a limited understanding of the other. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: Stopping short, spinning around, changing directions and/or speed at will, shifting its weight, bucking, rearing, kicking, biting, and/ or running from danger. I also acknowledge that these are just some of the risks and I agree to assume others not mentioned above. I am not relying on BLACK FOX FARM LLC to list all possible risks for me.
- D. ______ Conditions of Nature Warning, Unfamiliar and Sudden Sights, Sounds and Movements Warning, and Inspection of Premises. I/WE ACKNOWLEDGE THAT: BLACK FOX FARM LLC is NOT responsible for total or partial acts, occurrences, or elements of nature and/or sudden and/or unfamiliar sights, sounds and/or sudden movements that can scare a horse, cause it to fall, or react in some other unsafe way. SOME EXAMPLES ARE: Thunder, lightening, rain, wind, wild and domestic animals, insects, reptiles, which may walk, run or fly near, or bite or sting a horse or person; and irregular footing on out-of-door groomed or wild land which is subject to constant change in condition according to weather, temperature, and natural and man-made changes in landscape. I also understand that these are just some of the risks and I agree to assume others not mentioned above. I am not relying on THIS STABLE to list all possible conditions for me. The student and parent or legal guardian have inspected BLACK FOX FARM LLC's facilities and are satisfied that all premise conditions are reasonably safe for this student's intended purpose, usage and presence upon BLACK FOX FARM LLC's premises.
- F. _____ Carry-On Objects and Sharp Noises. I/WE UNDERSTAND THAT: Riders must not carry loose items on rides which may fall, blow away, flap in the wind, bounce, or make sharp noises, possibly scaring a horse. SOME EXAMPLES ARE: Cameras, hats not securely fastened under chin, toys, purses. Riders must not make sharp, loud noises, such as screaming or yelling, which may scare a horse.
- G. _____ Saddle Girths/Natural Loosening Warning. I/WE ACKNOWLEDGE THAT: Saddle girths (fastener straps around horse's belly) may loosen during riding. Students must alert the instructor or attendant of any girth looseness so action can be taken to avoid slippage of saddle and the potential for the rider to fall from the horse.
